Registration of transfers **Companies Act 2009**

The aggregate members of each shares must be stated, and the aggregate must be added up so as to agree with the number of shares stated in the summary of share capital and debentures to have been taken up.

When the shares are of different classes these column should be subdivided so that the number of each class held, or transferred must be shown separately where any share have been converted into stock the amount of stock held by each member must be shown.

The date of registration of each transfer should be given as well as the number of shares transferred on each date, the particulars should be placed together to that of the transferee, but the name of the transferee must be inserted in the "marks" column immediately opposite the particulars of each.

 If the return of either of the two preceding years was given as at date of that return the full particulars required as to past and present members

And the share and stock held and transferred by them. Only such of the particulars need to be given as related to person ceasing to be or becoming members since the date of the last return and to shares transferred since that date or changes as compared with date in the amount held by a member.
